SECTION 1: GUIDE TO BIDDERS

Preface

This document has been prepared by Reproductive Health Uganda (RHU) to solicit for quotations/letter of interest for the sale in one lot of 1,200,000 (One Million Two Hundred Thousand) Vials of 10ML bottles of Sterile Water for Injection BP pyrogen free(OTSUKA). Bidders are expected to provide the following information and it is that information that RHU will base the selection of the most preferred buy. We, therefore, kindly urge you to provide all the information that we need. The Bids shall be evaluated and the tender shall be awarded to the Bidder whose Bid has been determined to be the highest evaluated substantially responsive.

Eligibility

A bidder who may be a private or public entity incorporated in Uganda must be fully authorized by NDA to deal in wholesale trading of pharmaceutical products. In additional the bidder must provide evidence to show that they have a credible track record and operates in conformity with the provisions of the laws of Uganda.

Selection Criterion

This organization has a committee that evaluates and awards tenders to successful bidder based on information provided and any other relevant information that this organization may come across from any other credible source. The following is the minimum criterion that will be followed in selecting and awarding tenders:

- 1. Fully authorized by NDA to deal in wholesale business of pharmaceutical products
- 2. Highest Price
- 3. Operating in the framework of the government laws, and
- 4. Credibility of the supplier
